**14. Worplesdon Memorial Trustees** – To appoint a new parish representative to the Worplesdon Memorial Trustees following Mr Marks-Oldham's recent resignation.

**15.** Parking problems near Worplesdon Primary School – The concrete planters available from Guildford Borough Council are too large to fit onto the grass verge. To consider purchasing wood to enable four planters to be made (by the Assistant Clerk's family) 30cm x 1m, which will fit safely onto the verge.

**16.** Elections **2019**: To agree the date for the 'prospective candidates' event and to approve the various venue hire **costs** (costs currently anticipated to be no more than £250 & VAT).

**17. Grass cutting – St Mary's Churchyard** – To consider incorporating a set number of cuts within the Council's existing contract in lieu of a grant towards the upkeep of the Churchyard. Cost per cut £446.88 plus VAT per occasion. To remove dead tributes from the graves £45 per occasion & VAT.

**18.** Dangerous willow tree – Wood Street Village pond – The safety of this tree has been compromised. The tree therefore needs to be removed ASAP. Quotation received £620 & VAT. To approve the quotation.
