- Memorial bench the late Cllr Derek Slaymaker Letter to thanks received from Cynthia Slaymaker.
- Accidental mowing of the wildflower in Harry's Meadow Nurture Landscapes Ltd have been asked to replant bee friendly flowers in and around the commemorative bench as a gesture of goodwill.
- **UK Power Networks** new substation Pitch Place A complaint has been raised with UK Power Networks regarding their use of Pitch Place Green without permission. UK Power Networks has launched an investigation.
- **Dredging work by the National Trust Bowers Lock** As part of the initial groundworks some minor dredging was done in late February / early March immediately downstream of the weir gates to clear the weir channel. Some small side-casting of material may have occurred to allow boat access. No major dredging was carried out. The work is focussed on refurbishment of the weir gates and supporting structure and was unlikely to affect breeding fish.
