331-2022 - Memorial to Her late Majesty Queen Elizabeth II

Following discussion, it was proposed by Cllr J Messinger, seconded by Cllr M Price, and unanimously **RESOLVED** that the Parish Council order two memorial plaques in commemoration of the reign of Her late Majesty Queen II. One to contain the dates of her reign, the other to mark her personal connection to the parish of Worplesdon.

The personal connection being The Hon Andrew C Elphinstone (the Queen's nephew) who, in 1946, married a Lady in Waiting of Princess Elizabeth and subsequently (in 1953, the year of the Queen's Coronation) became the Rector of St Mary's, Worplesdon. The Elphinstone's lived in Maryland, Worplesdon. Princess Elizabeth (as she was at the time) became the Godmother of Rosemary Elizabeth Elphinstone. The Queen visited St Mary's Worplesdon on two occasions, being the Christening and marriage of her God daughter, Rosemary.

The plaques to be attached to the two newly installed tree guards on Perry Hill Green.

b) Draft budget for 2023/2024

The initial draft budget for 2023/2024 was presented to the meeting.

The RFO (Responsible Financial Officer) noticed a couple of minor errors during the presentation. The revised budget is to be considered at an Extra-ordinary meeting to be held on Tuesday 25 October 2022.

It was presently anticipated that the budgetary increase for 2023/24 will not exceed 5%.

c) Concurrent Functions Grant Aid 2021/2022

A grant of £4,375.00 has been received from Guildford Borough Council towards the installation of land drains in Jacobs Well Recreation Ground.

d) Memorial Bench for the late John Gunner

An emergency Concurrent Functions Grant of £3,568.50 has been awarded by Guildford Borough Council. The WSVA has also kindly offered to make a financial contribution towards the memorial bench (value unknown at the time of the meeting).

It was proposed by Cllr N Mitchell, seconded by Cllr J Messinger, and unanimously **RESOLVED** that the quotation from David Ogilvie Engineering be approved and accepted. Total cost including installation (and new base) £7,150 & VAT.

The exact location for the bench to be agreed with Steve Gunner but it likely to be situated on the triangular section of Wood Street Village Green as, being a metal bench, it is likely to get too hot to sit on if situated in the direct sun.

e) Replacement posts Perry Hill Green (wooden posts to be replaced with recycled plastic posts)
It was proposed by Cllr G Adam, seconded by Cllr J Messinger, and unanimously **RESOLVED** that the Parish Council approve the installation costs being a maximum of £1,800 & VAT.
