

## **PUBLIC NOTICE**

### **STRINGERS COMMON**

Worplesdon Parish Council has applied to the Secretary of State for Environment, Food and Rural Affairs for consent under section 38 of the Commons Act 2006 to carry out restricted works on Stringers Common. The Planning Inspectorate will decide the application on behalf of the Secretary of State. The proposed works are:

#### **Permanent Works – Accessway from Jacobs Wells Road into White House Lane (CL 352):**

To dig up 93m<sup>2</sup> of the existing track and replace with GC3 grasscrete (for soakaway purposes). Track dimensions = 31m in length by 3m in width.

To dig up and replace the existing 19m<sup>2</sup> bell mouth with tarmac – Bell mouth dimensions = 3.30m in depth by 8.3m at the widest part of the bell mouth.

To create four parking spaces amounting to 64m<sup>2</sup> to facilitate four parking spaces (large enough to accommodate disabled parking) to enable those who are disabled, or less physically able, to access the children's play area and to use the Recreational Ground for its intended purpose. The surfacing to comprise of GC2 grasscrete (for soakaway purposes). Dimensions = Length of parking spaces 10m by 6m in depth – with 1m x 2m splays at both sides of the car parking area (splays to be surfaced in concrete).

No trees will be required to be felled, and the root protection areas of the existing trees will not be compromised by the proposed location of the parking area.

The rear and partial sides of the parking area to be fenced for the prevention of accidents.
