



## **FLOOD PLAN**

**March 2025**

This Flood Plan has been created so that, in the event of flooding in the area covered by Worplesdon Parish Council, there is a clear understanding of the roles and responsibilities of the various agencies, and a list of contacts should residents require help in the event of an emergency.

### **FLOOD RISK AREAS:**

The following areas have historically suffered from flash/localised flooding:

#### **Fairlands:**

Community Centre  
Fairlands Medical Centre  
Gravetts Lane  
Gumbrells Close  
Quakers Way  
St Michael's Avenue  
Fairlands Avenue  
Fairlands Road

#### **Jacobs Well:**

Clay Lane

Frog Grove Lane junction with Aldershot Road  
Broad Street/Oak Hill – near the school

Halifax Close

## **Worplesdon:**

Worplesdon Road – A322  
Tangle Lane – Donkey fields  
Montague Place  
Stanford Brook and Holly Lane.

### **Causes of localised flooding:**

- Blockage of culverts, ditches and road gullies.
- Tree root infestation is a major cause of blocked culverts, drains and sewers. Therefore, residents should avoid planting trees near drainage pipes.

To prevent a blockage occurring, riparian householders should monitor culverts, ditches and bridges and make sure that they are kept clear of debris and are regularly de-silted.

As agreed with Guildford Borough Council, the Parish Council's Groundstaff to clear the debris grilles protecting culverts at the following locations:

1. Pound Lane/Baird Drive,
2. Oak Hill near Pound Lane,
3. Broad Street near the Pines and
4. Jacobs Well Road near "Moat House"

Grilles to be checked and cleared as necessary and up to three times a day during torrential rain.

It is the responsibility of individual householders to take whatever preventative measures necessary to avoid damage to their property in the event of a flood, i.e. installing appropriate drainage on their own property and keeping that drainage system clean and clear in the long-term, blocking air bricks, putting down sandbags, or placing protective boards across doors. Moving or keeping valuable belongings and documents upstairs or otherwise out of reach of rising levels of water.

### **Make an Emergency Flood plan for your own home:**

Make a list of useful phone numbers e.g. the emergency services, your insurance company and the Borough Council.

**Medication:** Would you need to take any with you if you had to leave your home?

**Gas and Electricity:** Do you know where to turn them off, even in the dark?

**Water:** Do you know where the stop cock is to turn off your water supply?

**Evacuation:** If you have to leave your home, what would you take with you and what provision can you make for family pets? If you have children, what would you need to take for them, perhaps sterilized bottles, nappies, spare clothing, a favourite toy or teddy?

### **Flood Triggers:**

Following periods of heavy rain it will be necessary to monitor debris grilles more often to make sure that they are clear of debris. It will also be necessary for riparian householders to check that the ditches are clear of debris.

### **Who does what during a flood?**

#### **Environment Agency**

- Issue Flood Warnings
- Receive and record details of flooding incidents
- Monitor the situation and advise other organisations
- Deal with emergency repairs and blockages on main rivers and own structures
- Respond to pollution incidents
- Advise on waste disposal issues

#### **Surrey County Council**

- Co-ordinate emergency arrangements
- Maintain safe conditions on the roads
- Put flood warning signs on the highway
- Organise road closures and traffic diversions
- Clear blockages on highway drainage systems
- May take action to protect property from flooding by water from the highway where there is a failure of the highway drainage system.

#### **Guildford Borough Council**

- Co-coordinating role for own area
- Flood warning dissemination (by local agreement with Environment Agency)
- Emergency assistance (S138 LGA 1972) — (limited supply of sandbags at several locations around Guildford — although Guildford Borough Council may not provide sandbags in future (cost-saving exercise))
- Clear blocked watercourses (Land Drainage Act powers)
- Act as County Council for highways (Highways Agency areas only)
- Environmental health issues — pollution
- Blocked road channels and gully gratings — street cleaning
- Emergency planning support groups
- Distribute sandbags from borough council stockpiles

## **Worplesdon Parish Council**

- Flood warning dissemination (by local agreement with Environment Agency)

## **Fire and Rescue Service**

- Respond to all emergency incidents as required
- Assist the residents where a need is identified and the use of Fire Service personnel and equipment is relevant

## **Water Companies**

- Emergency over pumping or tankering at pumping stations
- Clearing blockages in public sewers
- May take action to protect property from flooding by water from the public water mains or discharges from the public sewerage systems

## **Electricity, Gas and Telecommunications Companies**

- Attend to emergencies relating to their service at properties putting life at risk as a result of flooding
- Attend to flooding emergencies at their own service installations

## **Property Owners**

- Move to a safe area if life is at risk
- Prevent water from entering property if possible
- Switch off electricity, water and gas supplies at mains
- Move valuable possessions above areas liable to be flooded
