## 2025-143 - The late Cllr G Adam - 2-minute silence

It was with immense sadness and a very heavy heart that Cllr N Mitchell announced the unexpected passing of Cllr G Adam on Saturday 26 April 2025. Gordon joined the Parish Council in 2015, having previously served as a member of the public on the Parish Council's Traffic Committee. Gordon was elected to the position of Vice-Chairman in May 2022, and had also Chaired the Staffing Committee for five years.

Gordon had also been elected to serve on the following community organisations on behalf of the Parish Council: Slyfield Area Regeneration Plan, Fairlands, Liddington Hall and Gravetts Lane Community Association, and Worplesdon Memorial Trustees – where, in 2021, he was elected to serve as Chairman until his resignation in 2024.

Gordon's significant contribution to the Parish Council and the wider community will be keenly missed. A letter of condolence had been hand delivered.

Planning Application No: 25/P/00361 - 36 Stringers Avenue, Jacobs Well, Guildford, GU4 7NW - Advertisement consent application for 1no. illuminated fascia sign to replace existing signage above the shopfront.

It was **RESOLVED**: that the Parish Council request the installation of a non-illuminated sign. A large, illuminated sign at this parade of shops would be out of keeping and may cause light nuisance to residential properties given Jacobs Well is an unlit village.

It should be noted that parking at this parade of shops is extremely limited.

**Planning Application No: 25/P/00360 - 36 Stringers Avenue, Jacobs Well, Guildford, GU4 7NW** - Proposed installation of a condenser unit, a side window, fire door and the infill of the roller shutter opening.

#### b) Replacement light fittings in the first-floor Paish office

The ceiling light fittings in the first-floor Parish office are now obsolete. The ballast of yet another light fittings has blown and the replacement ceiling fitting above the desks is too bright causing health and safety concerns for the staff.

As a result, quotations had been sought from Broadwater Electrical Contractors Ltd. Two different styles of lights (both of which are dimmable) had been proposed. The first option being 'Juno' would cost £3,775.12 & VAT. The second option being 'Spektrum' would cost £3,362.37 & VAT.

The Clerk had contacted the landlords who were happy for either option to be installed but would have chosen the 'Spektrum' option from personal choice.

Due to the health and safety concerns, it was proposed by Cllr T Wright, seconded by Cllr N Crampin, and unanimously **RESOLVED** that both the Standing Orders and Financial Regulations be waived to enable the quotation for Option B 'Spektrum' to be approved.

The costs to be met from the office sinking fund budget.
