To report **crimes** or **anti-social behaviour** do this directly to **Surrey Police** on **101** or via their **website** (if non-urgent) and **999** (if urgent).

Thames Water can be contacted on **0800 316 9800** for **sewage** flooding.

Flooding on highways and footpaths should be reported to Surrey County Council on 0300 200 1003 or using https://tellus.surreycc.gov.uk/.

Fly-tipping on public highways or council land will be dealt with by **Guildford Borough Council**: www.guildford.gov.uk/reportflytipping.

■Big Changes Ahead? ■

Understanding Devolution and Local Government Reorganisation

As many residents may have heard, there are ongoing discussions about the future structure of local government in Surrey. These changes could have a major impact on the way local services are delivered — including here in Worplesdon. Worplesdon Parish Council is keeping a close eye on the developments and wants to ensure that our community understands what's being proposed, how it might affect you, and what role your parish council may play in the years ahead.

What Is Being Proposed?

Two key ideas are currently shaping the debate:

1. Devolution

Devolution means transferring more decision-making powers and funding from central government (in Westminster) to local or regional authorities. In practice, this could give councils greater control over:

- · Local transport and infrastructure
- · Housing and planning
- · Adult education and skills
- · Economic development

To secure these powers, local areas will be required to adopt new governance models — such as a directly elected mayor.

2. Local Government Reorganisation (LGR)

LGR would involve changing the current structure of local government in Surrey. At the moment, we operate under a two-tier system:

- Surrey County Council: responsible for services like education, highways, and social care.
- Guildford Borough Council: responsible for services like waste collection, local planning, and housing.

Under reorganisation, these will be replaced by unitary authorities — where one council delivers all local government services in a given area (e.g. West/East Surrey).

m What Are the Options?

Two models have been proposed by different councils:

Surrey County Council's Proposal

SCC has suggested creating two unitary authorities for the whole of Surrey — replacing all 11 borough and district councils.

They believe this would:

- · Streamline service delivery
- Eliminate duplication
- Reduce costs



District and Borough Councils' Proposal

Some district and borough councils, including Guildford Borough Council (GBC), have expressed concern about two centralised authorities. They are proposing the creation of three smaller unitary authorities, such as:

A "West Surrey" authority, potentially including Guildford, Surrey Heath, Waverley, and Woking.
 GBC say this would keep services more locally accountable and responsive.

■ What About a Surrey Mayor?

As part of any devolution deal, government policy currently requires the introduction of a directly elected mayor — similar to those in Greater London, Greater Manchester, and the West Midlands.

This "Mayoral Combined Authority" could:

- Secure extra powers and funding from central government
- Oversee major strategic decisions across Surrey

However, it would also mean that key decisions are made by a single elected individual, potentially increasing centralisation.

Potential Benefits Potential Concerns

Simpler council system

Loss of local representation

More efficient services

Larger, more remote authorities

Greater funding for Surrey Risk of local priorities being overlooked

In particular, services that affect daily life — road maintenance, planning, refuse collection, and housing — could all be managed by a larger authority, with fewer councillors and fewer local officers.

The Role of Parish Councils - A Growing Responsibility?

For areas like Worplesdon, the role of Parish Councils may become more important under any new structure.

If borough councils are removed, parish and town councils may be expected to:

- Take on more responsibilities, such as maintaining additional parks, community buildings, or minor planning duties
- Act as the local voice within a much larger governing structure
- Engage more actively with unitary authorities and potentially with a new Mayor's office This could offer opportunities to tailor services more closely to local needs — but also bring new demands in terms of funding, staffing, and training.

What Happens Next For Worplesdon?

No final decisions have been made. Discussions are ongoing between Surrey County Council, Guildford Borough Council, and the Ministry of Housing, Communities and Local Government (MHCLG). The government would need to approve any structural changes. The public consultation has now closed and the government will confirm their decision in Autumn 2025.

Worplesdon Parish Council believes that local voices must not be lost in any new system. We are:

- Monitoring proposals closely
- · Engaging with our borough and county representatives
- Preparing for the possibility of taking on greater responsibilities in the future

We are committed to keeping residents informed and will continue to represent the interests of the Worplesdon community throughout this process.
