Following discussion, it was proposed by Cllr N Mitchell, seconded by Cllr B McShee and unanimously **RESOLVED** that the Staffing Committee recommends that the Parish Council write to the Surrey Local Government Pension Scheme to request an estimate of the pension strain costs that may arise should the Council determine to exercise its discretion under Regulation 30(8) of the Local Government Pension Scheme Regulations 2013 to waive actuarial reduction on the Clerk's voluntary early retirement, with a response requested prior to the Full Council meeting scheduled for 9 April 2026.

It was further proposed by Cllr N Mitchell, seconded by Cllr B McShee and unanimously **RESOLVED** that subject to the LGPS response, the Full Council needs to consider the financial impact of the Clerk's formal request on the Council budget.
